### Application and dosage



For moisture-resistant floors.

Maintenance cleaning:  
20 - 100 ml/10 l cold water.



Scrubbing dryer:  
100 - 200 ml/10 l cold water.  
Pre-treat individual heavily soiled areas.



Single-disk machine:  
Yarn pad method:  
100 - 1000 ml/10 l water



Textile surfaces:  
Spray extraction/cleaning upholstery:  
200 - 1000 ml/10 l water.  
Spray onto surfaces and allow 5 - 15 minutes contact time. Rinse with spray extraction machine and clean water.  
Stain remover:  
1:1 to neat.

### Important information

Use cold water only.

On textile materials, please test the colourfastness and moisture resistance on a small, inconspicuous area beforehand.

When being used in the automat, the tanks should be regularly cleaned and rinsed.
