### Application and dosage



Opens up clogged drains, pipes, siphons, etc.



Use neat.

Light clogging:

Pour 50 ml of the product into the drain.

Contact time: 15 min.

Heavy clogging:

Pour 100 - 200 ml of the product into the drain.

Contact time: from 30 min. to 4 hours.

Rinse thoroughly with hot water.

Repeat treatment if required.
